PRELIMINARY

The Board decided to consider the Hon. Chief Justice as excused having noted the contents of his letter dated 20th June 2019.

In the absence of Hon. J, Jayasuriya, P.C., Chief Justice, Hon. Dr Bandula Gunawardena, Minister of Trade was appointed as Chairman pro tem to preside over the meeting.

PROCEEDINGS

CONFIRMATION OF THE MINUTES OF THE 89TH MEETING HELD ON 16TH JULY 2021

The Minutes of the 89^{th} Meeting of the Mahapola Higher Education Trust Fund held on 16^{th} July 2021 which had been circulated were approved by the Board subject to the

following amendment:

 Minute No. 17 — Board Paper No.15 — Service Extensions of the Temporary and Casual Appointments of MTF

It was pointed out that item (3) under the above minute should be amended to read as follows:

"3. Accounts Assistant – On casual days' pay basis. The service was extended up to 31st December 2021 as the Accounts Assistant is assigned to work at NWSL/NWCL as well."

Thereafter proposed by Mr. S.V.D. Kesarralal Gunasekera and seconded by Mrs. Bhadranie Jayawardhana, the Chairman pro tem. signed the minutes as a correct record of the proceedings.

2. MATTERS ARISING FROM THE MINUTES

2.1 Amendment of Mahapola Act No.66 of 1981

Mr. M.P. Bandara, Director informed that, the Attorney General's Department was informed of the proposed amendments to the Act, as taken up at the last Meeting of the Trustees but the Trust has not had a response to date.

2.2 APPOINTMENT OF THE DIRECTOR FOR MAHAPOLA TRUST FUND AND APPROVAL FOR THE REMUNERATION PACKAGE FOR THE POST OF DIRECTOR

The Board having re-considered the Board paper 13 of the 89 th Meeting of the Board together with the letter dated 2nd July 2021 from Mrs. Bhadranie Jayawardhana, Secretary, Ministry of Trade with regard to the request made by the Director, Mahapola Higher Education Scholarship Trust Fund with regard to accepting the position of Director and placing him on a suitable salary scale, was taken up by the Board.

The Board having considered the request made by Mr. M.P.Bandara, Director and the recommendation of the Secretary, Ministry of Trade approved the following salary and allowances to Mr. M.P. Bandara, Director with effect from 3rd June 2021.

3. BOARD PAPER NO.1 RE-LAUNCH OF THE MAHAPOLA ONLINE LOTTERY

Mr. M.P. Bandara, Director tabled Board Paper No.1 in connection with the above.

Mr. M.P. Bandara, Director informed the Board that as per the discussion at the Meeting of the Board of Trustees, held on 16th July 2021, arrangements are being made to introduce a new online lottery called "Mahapola".

Mr. Bandara informed the Board that, since the approval of the Cabinet of Ministers has to be obtained in order to launch this new online lottery, a copy of the draft Cabinet Memorandum which has been prepared seeking cabinet approval was tabled the contents of which was noted by the Board.

The Hon. Minister informed the Board that, there is a Cabinet decision that the Treasury will fund the Mahapola Higher Education Scholarship Trust Fund although previously the Minister of Finance had indicated that the Treasury provisions for the payment of Mahapola scholarship installments will be decreased.

Mr. S.V.D. Kesrralal Gunasekera, Appointed Trustee requested Mr. Bandara to table a Paper at the next meeting, on the Mahapola Funds received from the Treasury during this year, for the information of the Board.

The Board having noted the contents of the Paper on the launching of the new online lottery approved of the following subject to receiving Cabinet approval.

- i. To appoint an experienced person on contract basis for a specific period to coordinate procurement affairs of the new lottery.
- To carry out all the procurement affairs together by the MTF and the Ministry of Trade.
- iii. To appoint a Technical Evaluation Committee (TEC) on the approval of the Cabinet of Ministers and to prepare guidelines for conducting of the lottery.
- iv. To appoint a Procurement Committee upon receipt of the cabinet approval and to call Expressions of Interest (EOI) under its approval.

S.S P Corporate Services (Private) Limited

The Board was informed that Mr. Sena Suriyapperuma will prepare the necessary documentation in this connection. However, with regard to the Web security platform, it was decided to publish an advertisement and call for interested parties to quote for same.

The Chairman pro tem. requested Mr. Bandara to table a Paper on the above at the next meeting.

4. BOARD PAPER NO.2

TO SUBMIT BUDGET ESTIMATES OF THE MTF FOR THE YEAR 2022 FOR THE APPROVAL OF THE BOARD OF TRUSTEES

Mr. M.P. Bandara, Director tabled Board Paper No.2 in connection with the above.

The budget estimates of MTF for the year 2022 which was circulated among the members previously was taken up for discussion.

The budget estimates covered the following:

- Income and Expenditure Estimates 2022 and notes
- Recurrent Expenditure Estimates 2022 and notes

Referring to the Income and Expenditure Estimates for 2022, the Chairman pro tem. pointed out that the Trust should plan to hold a Mahapola Fair before the 2022 New Year, between the 1st to the 13th of April 2022 and budget an income of Rs.50 Mn from the Mahapola Fair. Dr. Ravi Liyanage, Trustee suggested that the Fair be held in the premises of a School. Prof. Kapila Perera, Secretary, Ministry of Education stated that the School could be organized for this purpose. The Board noted that the Online Lottery promotion could also be carried out at this Fair. The Board that the Trust hopes that the health authorities will grant the Trust permission to hold this Fair.

Dr. Ravi Liyanage referring to the budget estimates inquired on the increase in Personal Emoluments. Mr. M.P. Bandara explaining stated that this was due to the recruitment of an Internal Auditor and an Accountant to the Trust.

Mr. Bandara, was requested to submit a revised budget for the approval of the Board.

Mr. M.P. Bandara tabled copy of the Minutes of the 8th Meeting of the Investment

Committee held on 27th January 2021 for the information of the Board.

The Board having noted the contents approved the following recommendations of the Investment Committee

- To call Expression of Interest (EOI) to obtain the service of an appropriate person
 with expertise in preparing project reports and feasibility reports for the
 proposed projects to be implemented under the Mahapola Higher Education
 Scholarship Trust Fund and obtain the service of a suitable service supplier.
- ii. To obtain the service of Prof. P.K.S. Mahanama DVC and the Dean of the Faculty of Town and Country Planning of the University of Moratuwa for initial design of Metro-trade city project, Anuradhapura (a copy of his Curriculum Vitae was tabled).
- To purchase a new accounting software (Accpac) for MTF (a copy of the proposal was tabled).
- iv. To fill the vacancies for the posts of Accountant and Internal Auditor for the MTF which are to be filled immediately.
 - The Board having noted the requirement to appoint an Accountant urgently approved the appointment of an Accountant on an acting basis until á permanent Accountant is appointed by the Board.

BOARD PAPER NO.5

PRESENT PROGRESS OF THE AFFILIATED INSTITUTES OF THE MAHAPOLA TRUST FUND

Mr. M.P. Bandara, Director tabled Board Paper No.5 in connection with the above.

The Board noted the following:

Sri Lanka Institute of Information Technology (SLIIT)

The final report prepared by the Chairman of COPE based on the special audit report of the Auditor General on the affairs of the SLIIT has been tabled in Parliament by the Chairman of COPE. The report consists of the replies and measures of the Hon. Minister of Trade and in-charge of the subject of Mahapola has been sent to the Secretary General of Parliament and a copy of same was tabled for the information of the Board.

Mr. Palitha Kumarasinghe, P.C. was appointed under the approval of the Board of Trustees to look into misuse of the assets of MTF by the agreement with SLIIT and a copy of the report prepared by him was tabled for the information of the Board of Trustees.

The Board having noted the above recommended that the Investment Committee should study this Report separately and submit their recommendations to the Board.

- ii. Progress in the judiciary affairs of liquidating the Nat Wealth Securities Limited (NWSL) and National Wealth Corporation Limited (NWCL).
 - a. As per the repurchasing loan agreement of the NWSL, the Commercial High Court has made an order to NWCL to pay the due balance of Rs.126 Mn to the Trillion Security Ltd. and the case was terminated by paying an amount of Rs.95 Mn, under the approval of the Liquidation Committee and the Board of Directors and the final approval of the Board of Trustees.
 - b. The proposal for making a final decision on the due amount payable to the Virtual Trading Company Limited, by NWCL for re-purchasing was submitted to the Cabinet of Ministers and the Cabinet appointed a committee to look into this matter and submit a report based on its decision and a copy of the said report was tabled for the information of the Board of Trustees.

The Report of the committee will be submitted to the Cabinet of Ministers and future measures will be taken based on its final decision.

- c. The case filed by NWSL and the investigations of the CID will be continued and a lawyer has been appointed with the approval of the Board of Directors of NWSL to examine them. The investigations have been delayed due to the COVID-19 pandemic.
- d. Annual Report and Auditor General's Report of NWSL and NWCL have been received are tabled at this meeting for the information of the Board of Trustees.

8. BOARD PAPER NO.6 PROPOSAL ON PROVIDING A TECHNOLOGY ASSISTED EDUCATIONAL PROGRAMME FOR REMOTE AREAS

Mr. M.P. Bandara, Director tabled Board Paper No.6 in connection with the above.

The Board noted that as approved by the Board at the meeting held on 16th July 2021, the University of Kelaniya has developed the above proposal "Smart Postman – Connect Unconnect online technology assisted educational programme" for the students in remote areas.

A copy of the Proposal was tabled for the information of the Board.

The Board noted that it is proposed to implement this project as a pilot project to evaluate the outcome, draw backs and identify improvements needed and this will help to gather experience in introducing the foreign language University College on digital platform (online).

The Board having noted the above approved the following:

- i Implementation of the above proposed technology assisted educational programme prepared by the University of Kelaniya E Learning Centre.
- ii. The payment of 50% of the estimated cost of Rs. 10 Mn for the 1st phase of the pilot project with the cost in respect of the 2nd phase to be recommended only on successful implementation of the 1st phase.

9.1 Minutes of the 9th Meeting of the Investment Committee of the Mahapola Higher Education Scholarship Trust Fund

Mr. M.P. Bandara, Director circulated among the Members copies of the Minutes of the 9th Meeting of the Investment Committee of the Mahapola Higher Education Scholarship Trust Fund, the contents of which was noted by the Board.

9.2 Investment Portfolio Summary

Mr. M.P. Bandara, Director circulated among the Members copies of the Investment Portfolio Summary of MTF as at 22nd September 2021, the contents of which was noted by the Board.

9.3 Allocation of part of the land at Millawatte in respect of the proposed INDUSTRIAL Park with in the International University Village

Mr. M.P. Bandara, Director tabled copy of a letter received from the State Ministry of Urban Development Coast Conservation, Waste Disposal and Community Cleanliness of the Urban Development Authority informing the Secretary, Ministry of Trade that the land at Millawa (123acres) has been allocated in respect of the proposed International University Village to be established under the Mahapola Higher Education Scholarship Trust Fund. Further, Dr Ravi Liyanage has proposed to allocate the part of the Land for the establishment of the Industrial Park and the training institutes for the industrial training seekers both students and the technical officers of the privet sector and
