PROCEEDINGS

The Board noted that Hon. H.N.J. Perera, Chief Justice wished to be excused.

Hon. Lucky Jayewardena, Acting Minister of City Planning, Water Supply and Higher Education was appointed as the Chairman pro tem. to preside over the meeting. The Chairman pro tem. welcomed the members to the meeting.

1.CONFIRMATION OF THE MINUTES OF THE 73RD MEETING HELD ON 2ND APRIL 2019

The Minutes of the 72nd Meeting of the Mahapola Higher Education Trust Fund held on 2nd April 2019 which had been circulated were approved by the Board and signed by Mr. S.V.D. Kesarralal Gunasekara, Appointed Trustee, as a correct record of the proceedings.

2.MATTERS ARISING FROM THE MINUTES

There were no matters arising from the Minutes of the previous meeting

3.BOARD PAPER NO.1 AMENDMENT TO THE MTF ACT NO.66 OF 1981

Mr. M.P. Bandara, Director tabled Board Paper No.1 in connection with the above.

The Board noted that His Lordship the Hon. Chief Justice has submitted a letter addressed to the Secretary to His Excellency the President with copies to all the trustees regarding the amendment of the MTF Act No. 06 of 1981 amending the Sec 3(2)(b)(i).

A copy of the letter addressed to the Secretary to His Excellency the President was tabled for the information of the Board.

Mr. M.M.P.K. Mayadunne, Secretary, Ministry of City Planning, Water Supply and Higher Education explained to the Board and the Chairman pro tem., that the Hon. Chief Justice was appointed as the Chairman of the Trust, as per the Act, in order to protect the interest of the Trust.

Mr. Kesarralal Gunasekara, Appointed Trustee at this stage stated that the former Chief Justice Sarath N. Silva who was the Chairman of the Trust previously, specified that he will not participate in any commercial decisions.

Accordingly the Board decided to write to the Hon. Chief Justice, setting out in detail the view of the Board of Trustees in connection with the above and that it is in order to protect the interest of the original Act of the Mahapola Higher Education Scholarship Trust Fund that the Board wishes him to continue as Chairman of the Board.

4. BOARD PAPER NO.2 SCHEME OF RECRUITMENT (SOR) OF MAHAPOLA HIGHER EDUCATION SCHOLARSHIP TRUST FUND

Mr. M.P. Bandara, Director tabled Board Paper No.2 in connection with the above.

The Board was informed that MTF has prepared the SOR and submitted same for the approval of the Board of Trustees at its 73rd Meeting held on 2nd April 2019. The Hon. Minister at that meeting requested the Board to allow him time to study the SOR and submit observations. The Board noted that since MTF is not subjected to any Ministry supervision and it is an independent fund, it is not necessary to get the approval from the Department of Management Services for MTF's SOR or Cadre.

The Board noted that according to the provisions of the MTF Act No.66 of 1981, the Board of Trustees has the sole power and authority to recruit and remunerate the employees of MTF.

The Board having noted the above approved the draft Scheme of Recruitment for the positions indicated in the Organization Structure of MTF which was prepared by MTF following the Department of Management Services and Public Administration Circular Guidelines.

5. BOARD PAPER NO. 3 APPOINTMENT OF ASSISTANT DIRECTOR FINANCE AND ASSISTANT DIRECTOR (IT & PROJECTS) FOR MTF

Mr M.P. Bandara, Director, tabled Board Paper No.3 in connection with the above.

The Board having noted the contents of the Board Paper and that there are vacancies in the cadre approved

- i. The recruitment of 02 Assistant Directors for the post of Finance, IT and Projects for the staff of MTF.
- ii. The publishing of the advertisement for the above two Assistant Directors vacancies in the Daily Newspaper and weekend newspapers calling for applications for the posts.

6. BOARD PAPER NO.4 RECRUITMENT OF 05 MANAGEMENT ASSISTANTS FOR MAHAPOLA

Mr. M.P. Bandara, Director, MTF tabled Board Paper No.4 in connection with the above.

The Board having noted the contents of the Board Paper approved

- i. The list of applicants selected by the Interview Board for the post of Management Assistant Grade III for filling of vacancies in MTF and their appointment with effect from 10th August 2019.
- ii. The marks in respect of the structured interview for the selection of applicants for the post of Management Assistant of MTF.

The Board was informed that the basic salary on commencement of employment will be Rs. 31,000/- per month.

7 BOARD PAPER NO.5 LAND FOR ESTABLISHMENT OF MAHAPOLA HEAD OFFICE

Mr M.P. Bandara, Director, MTF tabled Board Paper No.5 in connection with the above.

The Board having noted the contents of the Board Paper

 Ratified the request submitted to the Ministry of Mega polis and Western Province Development for a suitable land, by the Secretary, Ministry of City Planning, Water Supply and Higher Education, for the establishment of the Mahapola Head Office

- ii. Approved the publishing of a newspaper advertisement in the daily and weekend newspaper for well-wishers who are willing to donate a land for the establishment of MTF Head Office.
- iii. Directed the Director, MTF to check on the possibility of obtaining the land situated at Padanam Mawatha, Colombo 7
- iv. To write to the Public Trustee and check on the possibility of obtaining Mr. J.R. Jayawardene's former residence for the establishment of the MTF head office.
- v. To check on the possibility of obtaining the land situated at Baudhaloka Mawatha which is coming under the purview of the University of Kelaniya.

Mr. S.V.D. Kesarralal Gunasekara, Appointed Trustee informed the Board that a land in extent of 60-70 Perches would be sufficient to establish an Office for MTF.

Mr. Nihal Ranasinghe, Secretary, Ministry of Education requested for a copy of the letter sent to the UDA with regard to the above, in order to pursue the matter with Mr. Chandana of the UDA.

8. BOARD PAPER NO.6 CURRENT POSITION OF NWSL ON SUSPENSION OF THE PRIMARY DEALER LICENSE BY CBSL

Mr. M.P. Bandara, Director tabled Board Paper No.6 in connection with the above.

The Board was informed that due to some regulatory issues, core capital requirement and outstanding tax liability with the litigation against NWSL, CBSL issued a show cause letter on 25th January, 2019 and NWSL submitted their explanation on 14th February 2019 considering the continuous failure to comply with the directives applicable to primary dealer, CBSL has decided to suspend NWSL from carrying on business and activities of primary dealer for a period of six months with effect from 4.30 p.m. on 31st March 2019.

The Board was informed that the Secretary, Ministry of City Planning, Water Supply and Higher Education sent a letter addressed to the Governor CBSL requesting a fully report on the suspension of Primary Dealer License. The Director MTF has also requested from NWSL to submit a detailed report in this regard.

The Board was also informed that as per the approval of the Cabinet, the Procurement Process commenced and the Standard Cabinet appointed Technical Evaluation Committee (SCATEC) had two meetings and the draft EOI (bidding document) is being prepared on the sale of shares of NWSL to a new investor.

The Board was informed that this matter was taken up at the previous meeting of the Board of Trustees. The Board was informed that the Hon. Minister's concern was to reactivate the business of NWS: with the sound management as primary dealer NWSL is having the potential to earn profit and is also fully owned entity of MTF.

The Board having noted the contents of the above Paper approved the proposal to submit a fresh cabinet paper to reactivate the business under the MTF ownership,

9. BOARD PAPER NO.7 MINUTES OF THE 1ST MEETING OF THE INVESTMENT COMMITTEE OF MTF

Mr. M.P. Bandara, Director, MTF tabled Board Paper No.7 in connection with the above.

Mr. M.M.P.K. Mayadunne, the Secretary, Ministry of City Planning, Water Supply and Higher Education, Chairman of the Investment Committee explained the functions of the Investment Committee to the Chairman pro tem.

It was suggested to summarize the investments of the Company for the information of the Board in future.

Mr. M.P. Bandara, Director summarizing informed the Board that a sum of Rs.10 Bn is invested with Bank of Ceylon in various securities and the Company obtains an income of approximately Rs.900 Mn per year. In addition the Company has received Dividends of approximately Rs.140 Mn during the last 15 years. The Company has paid tax of approximately Rs.700 Mn and a sum of Rs.150,000/- is payable as Legal Fees.

The Board having noted the Minutes of the Investment Committee held on 29th May 2019 (which was approved by the Chairman of the Investment Committee i.e. Secretary, Ministry of City Planning, Water Supply and Higher Education) approved the said Minutes.

10. BOARD PAPER NO.8

APPOINTMENT OF INTERNAL AUDITORS FOR MAHAPOLA HIGHER EDUCATION SCHOLORSHIP TRUST FUND

Mr. M.P. Bandara, Director, tabled Board Paper No.8 in connection with the above.

The Board was informed that as per the National Audit Bill No.19 of 2018, it is required to appoint an Internal Auditor for each government organization.

The Board was informed that as informed by the Secretary Ministry of City Planning, Water Supply and Higher Education, it was proposed to outsource the Internal Audit function and accordingly quotations were called from Auditors registered with the Institute of Chartered Accountants of Sri Lanka and having a practicing certificate. The Board noted that the lowest quotation was received from M/s B.R. De Silva & Co., Chartered Accountants.

Mr. M.M.P.K. Mayadunne, Secretary, Ministry of City Planning, Water Supply and Higher Education informed the Board that he has written to the Auditor General in this connection and is awaiting his response.

Mr. N. Ranasinghe, Secretary, Ministry of Education explaining stated that an Internal Auditor should be an individual. He stated that an individual will look at something before taking action, whereas an independent person will give a view after taking action.

Accordingly the Board decided to take a decision on the above matter at the next Meeting.

APPROVAL FOR THE INVESTMENT MADE ON EXCESSIVE FUND OF MTF FROM 1/1/2019 TO 30/40/2019

Mr. M.P. Bandara, Director, MTF tabled Board Paper No.9 in connection with the above.

The Board having noted the investments of excessive funds made by the Company during the period 1st January 2019 to 30th April 2019 i.e. prior to the establishment of the investment committee granted covering approval therefor.

Mr. M.M.P.K. Mayadunne, Secretary, Ministry of City Planning, Water Supply and Higher Education referring to the interest rates stated that normally in the beginning of the year interest rates offered are low while at the end of the year interest rates are generally high because the Government takes more loan towards the end of the year.

Hon. Lucky Jayewardena, Chairman pro tem. stressed that the Company should earn the maximum interest rate.

12. BOARD PAPER NO.10

RE-STRUCTURING OF THE MONTHLY SCHOLARSHIP PAYMENT SYSTEM – SMS SERVICES

Mr. M.P. Bandara, Director, MTF tabled Board Paper No.10 in connection with the above.

Mr. M.P. Bandara informed the Board that as approved by the Board of Trustees the monthly scholarship system has been re-structured in order to pay the scholarship installment on a specific date of the month for all the students directly by crediting to their Bank Accounts by MTF.

The Board was informed that when the new system operates, students will be notified with regard to their installment payment via SMS immediately after crediting their Bank Account.

The Board having noted that ICTA is not in a position to provide the SMS service due to an internal matter decided to cancel the agreement signed with ICTA for providing of SMS Gateway facility for MTF.

Mr. M.M.P.K. Mayadunne, Secretary, Ministry of City Planning, Water Supply and Higher Education explaining stated that students will need a sum of at least Rs.12,000/-minimum for a month and therefore MTF should try and save and increase the Mahapola allowance for the students.

The Board having noted the above decided to speak to the Bank and get the Bank to forward an SMS to the recipients no sooner their installment payment has been made instead of signing an agreement with Dialog Axia PLC for providing of SMS gateway facility which will cost approximately Rs.70,000/-.

APPROVAL FOR OBTAINING ONLINE INTERNET BANKING FACILITY (FOR OBTAINING BANK STATEMENT AND TRANSACTION VIEW ONLY)

Mr. M.P. Bandara, Director, MTF tabled Board Paper No.11 in connection with the above, the contents of which were noted.

It was resolved:
